League will require games to be played at different field sites. *Some fields may go down for refurbishment during part of the season.* 12-13 regular season games will be scheduled. (Subject to change) Playoff for teams that qualify. Due to the increased number of regular season games (previously only 10) and time constraints, games (e.g. rain-outs, suspensions, etc.) may not be rescheduled. Baseballs must be picked up by 3rd game of the season.

Forfeit Bonds are subject to revocation for any of the following reasons:

1. Failure to play games as scheduled;
 2. Withdrawal during a league;
 3. Failure of any player to abide by an umpire's decision;
 4. Failure to be active for a period of three (3) consecutive years.
 5. Unsportsmanlike or improper conduct (fighting, smoking, alcohol/drug use or possession, use of obscene language, etc.)
- Note: Suspension or revocation of Forfeit Bond may result from any of the above. Forfeit Bonds will revert to the Municipal Sports Account to be used in further promotion of Sports Activities.
